A. Action Items

1. Review and recommendation of designs for the electrical boxes' public art project

Ms. Carlson and Janet Passek requested RAP tax funds from the Town Council to wrap seven utility boxes in Springdale with designs from local artists. To achieve this, they held a contest with the theme "What I love about Springdale" and invited artists to submit designs for the three different box sizes. The Art Review Board members needed to review the submissions and select the designs to recommend to the Town Council for consideration. The Board needed to consider the box dimensions to envision how the various designs would fit. An expert will be consulted to scale and photograph the chosen designs, which will then go to the sign manufacturing company in Saint George for vinyl wrap creation and installation. The selected artists would sign a release of their artwork and receive a \$250 stipend. Ms. Carlson and Ms. Passek will identify which utility boxes in Springdale would be selected for the project, considering recommendations from the streetscape committee.

Ms. Zumpft asked if the warning labels were required to be on the boxes.

- Ms. Carlson stated that a conversation with Rocky Mountain Power was planned to discuss the requirements for the warning labels and the possibility that they could be moved or adjusted.

The Board members compiled their top seven picks to see which designs had the highest votes.

The board members selected five submissions for the utility box project.

- Submission 5 was chosen for the way the artist envisioned the design and its simplicity.
- Submission 11 was selected, but they requested more contrast on the side with the tortoise, as it may get lost in the design. They suggested contacting the artist to see if they could add more contrast.
- Submission 16 was chosen for the detail in the artwork and how it was planned to fit onto the box.
- Submission 17 was selected for its simplicity and creative design.
- Submission 18 was selected because of its stunning display at different times of the day.

The members of the Art Review Board commended the artists for the designs submitted. They appreciated the designs in keeping with the theme and envisioned them on the boxes.

Motion made by Lisa Zumpft to recommend the Town Council approves the submissions 5, 11, 16, 17, and 18 to be selected to move forward in creating final art for the electric box public art project. Additionally, number 15 and the top design on number 8 were selected as runner-up projects if necessary. Seconded by Mike Alltucker.
